OCI Seating Freight Program

Standard shipments made via the OCI Seating freight program are made via common carrier unless otherwise specified. Special routing request made by the customer or the consignee may result in additional charges.

Standard deliveries are dock-to-dock and are scheduled to occur Monday thru Friday between the hours of 8 a.m. and 5 p.m. not including holidays. We will not be held responsible for issues or costs arising from carrier transit delays, missed delivery appointments, ect. Standard delivery doesn't include expedited shipping, inside delivery, residential delivery, lift gates, installation, unpacking or removal of carton or packing materials, limited access or remote (areas outside major metropolitan areas). OCI Seating reserves the right to charge for nonstandard customer deliveries. For information concerning these charges, contact Customer Service.

Shipments from zone 1 being shipped to any other zone may be subject to changes in discounting. Contact OCI for more information.

Freight Terms

Freight terms apply to the continental U.S. only. This excludes Alaska, Hawaii and Puerto Rico. Shipments to Alaska, Hawaii and Puerto Rico will be made to the appropriate point of embarkation. The OCISeating freight program for all standard deliveries of our product is based on our minimum shipment values shown in both tables below. If the value of the shipment falls under the minimum requirement, a freight surcharge per shipment will be added based on the destination territory as listed on the map below. OCI Seating products can be combined with the KD Freight program to meet the minimum shipment value.

Based on the fluctuation of fuel prices; we reserve the right to impose a freight surcharge for any shipments.

The OCI Seating freight program does not apply to "Will Call" orders.

For shipments of components parts, fabrics and textiles, actual freight charges will apply and will be invoiced to the customer.
